Action plan will improve the policy instrument: Type 1 (the ERDF will provide funding)

Meetings related to the Action plan

- Part1: Presenting the characteristics of an Action Plain and highlighting the role of stakeholders in its definition and implementation.

- Part 2: Presentation of 5 Good Practices in circular economy published in the Interreg Europe Policy Learning Platform. The stakeholders carried out a working session, to debate the transferability and adaptability potential to the Aragon context

Identification of strategic lines, good practices and actions from other Interreg projects to feed the actions of the first Action Plan draft.

Bibliographic review



- Review of strategic documents and European, Spanish and Aragonese policies
- Review of other Interreg Projects and identification of 88 actions related to Interreg CECI
 - EXAMPLES OF PROJECTS: Interreg ECOWASTE4FOOD, Interreg BIOREGIO, Interreg CESME, Interreg CirCE, Interreg WINPOL, among others)
- Analysis of 150 Good Practices and identification of 80 which are related to Interreg CECI (GP from Interreg CECI, other Interreg projects and other sources)
- Assessment of the transferability of policies, strategic lines, actions and good practices according to the RICE methodology (Reach, Impact, Confidence, Effort)



RICE Methodology

The **RICE methodology** has been applied to assess the **transferability** of the initiatives identified:

- Reach (R): Dimension of the impacted group.
- Impact (I): Positive magnitude of the impact in relation to the needs of the project.
- Confidence (C): Probability of a successful materialization
- Effort (E) : The effort required for its implementation.

RICE = $(R \times I \times C) / E$

For the analysis of the relevance of the strategies considered in the framework of the CECI project, it has been assessed:

- **The interest** that the line of action defined in the strategies for the Government of Aragon (computed as RxIxC (numerator)).
- The feasibility of implementation taking into account the institutional and financial capacity of the possible driving agents (computed as the inverse of the effort (1 / E))



Action Plan Progress



- A total of "25 action lines" were initially proposed divided into 6 strategic lines/topics:
 - Institutional framework
 - Durability and life cycle of products and goods
 - Waste reduction
 - Food Waste
 - Sustainable and shared mobility
 - Sensitization/Awareness

The Action Plan will finally be focused on: i) Durability and life cycle of products, ii) Waste Reduction and iii) Sensitization/Awareness.
