
## All Territories are reviewing their Waste Plans towards the circular economy, also in Aragón, GIRA Plan.



### **Stakeholders meeting Semester 3:**

There was a semi face-to-face meeting on September 10.

#### The circular economy GP were presented in.

- B/S/H Home appliances Preparation for Reuse. On-line sales.
- University of Zaragoza, explained its experience of GP circular economy in general: in particular, an interesting donation of some furniture for later reuse.
- Mercadona -the largest group of Spanish supermarkets- which is using "agricultural plastic waste" as row material in the production process of different household cleaning items (bucket, brush, etc.).
- The Ministry of Ecology, Transition and Demography (MITERD) presented us its "Catalog of Good Practices for Circular Economy", which belongs to the Spanish Strategy for Circular Economy 2030. Possible synergies between this catalog and CECI were discussed at the meeting. Thanks to this, MITERD also knows CECI, very important as a dissemination action of CECI in national level.
